

LS&Co. Limited Warranty
Levi's® Commuter™ Trucker Jacket
with Jacquard™ by Google

Levi's Strauss & Co. (Levi's®) stands behind the quality of everything we sell, and we want you to be happy with your Levi's® Commuter™ Trucker Jacket with Jacquard™ by Google (the "Jacket"). This limited warranty applies solely to the apparel elements of the Jacket, such as the fabric, stitching, buttons, and construction (the "Trucker"), and specifically excludes the Jacquard elements of the Jacket, including the Jacquard conductive threads, the Jacquard snap located in the Jacket's left sleeve cuff, and the Jacquard snap tag that attaches to the Jacquard snap (whether an original or replacement tag). The Jacquard elements are covered by the limited warranty provided by Google.

Due to its unique nature, the Trucker has a limited 1-year warranty against manufacturing and material defects (aside from normal wear and tear).

If you feel your garment is defective, you can send it into to us to be inspected. If your garment is found to be defective, it will be replaced with the same or similar garment. If it is not found to be defective, it will be returned to you with a letter of explanation.

For warranty evaluation, your product must be returned directly to Levi's® and sent to:

All warranty-related shipping must be pre-paid, and we suggest insured. State law requires that products accepted for review are clean.

THE LIMITED WARRANTY WRITTEN ABOVE IS THE ONLY EXPRESS WARRANTY LEVI'S PROVIDES FOR THE TRUCKER, AND THE ABOVE REMEDY IS YOUR SOLE REMEDY. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, LEVI'S EXPRESSLY DISCLAIMS ALL OTHER WARRANTIES AND CONDITIONS OF ANY KIND, WHETHER STATUTORY OR IMPLIED, ARISING FROM COURSE OF CONDUCT OR OTHERWISE, REGARDING THE TRUCKER, EXCEPT THAT ANY IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON-INFRINGEMENT ARE LIMITED IN DURATION TO ONE YEAR.

Some States do not allow limitations on how long an implied warranty lasts so the above limitation may not apply to you.

What does this warranty not cover? This limited warranty is only valid and enforceable in locations the Jacket is sold and will apply only if you purchased your Trucker from Levi's, Google or their authorized resellers. This limited warranty only applies to the Trucker, and this limited warranty does not apply to damage caused by normal wear and tear.

YOU EXPRESSLY UNDERSTAND AND AGREE THAT, TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, LEVI'S AND ITS SUBSIDIARIES AND AFFILIATES (COLLECTIVELY, "LEVI'S PARTIES") SHALL NOT BE LIABLE TO YOU UNDER ANY THEORY OF LIABILITY (WHETHER CONTRACT, TORT (INCLUDING NEGLIGENCE), BREACH OR FAILURE OF ANY WARRANTY OR OTHERWISE) FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL OR EXEMPLARY DAMAGES THAT MAY BE INCURRED BY YOU IN CONNECTION WITH THE TRUCKER, JACKET, JACQUARD, THE REPLACEMENT TAG, OR THESE TERMS, INCLUDING ANY LOSS OF DATA, WHETHER OR NOT A LEVI'S PARTY OR ITS REPRESENTATIVES HAVE BEEN ADVISED OF OR SHOULD HAVE BEEN AWARE OF THE POSSIBILITY OF ANY SUCH LOSSES ARISING. YOU EXPRESSLY UNDERSTAND AND AGREE THAT, TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, THE LEVI'S PARTIES' TOTAL LIABILITY IN CONNECTION WITH THE TRUCKER, JACKET, JACQUARD, THE REPLACEMENT TAG, AND THIS LIMITED WARRANTY WILL NOT EXCEED THE AMOUNT YOU ACTUALLY PAID FOR THE JACKET AT RETAIL.

Some States do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.

If any term of this limited warranty is held to be illegal or unenforceable, the remaining terms of this limited warranty will remain in full force and effect.

How State and other laws apply to you: This warranty gives you specific legal rights, and you may also have other rights which vary from jurisdiction to jurisdiction.
